The regular meeting of the State Board of Examiners was called to order pursuant to Idaho Code §67-2002 and by the order of the chair at 8:55 a.m.

The following members were present: Governor C.L. "Butch" Otter, Secretary of State Lawrence Denney, and Attorney General Lawrence Wasden. State Controller Brandon Woolf recorded the proceedings of the meeting.

7. State Treasurer- Recommend Approval

Request authorization pursuant to Idaho Code § 63-3201 to issue tax anticipation notes that will not exceed 75% of the anticipated income or revenue from taxes during fiscal year 2019.

State Controller Woolf introduced the regular agenda item.

Discussion: State Treasurer Crane spoke on behalf of the Treasurer's office. He stated they were there to request approval for the annual tax anticipation notes. Last year they issued 485 million, the interest rate they paid was 98 basis points (.98%). They did not know what the rate will be this year. Governor C.L. "Butch" Otter asked what they anticipate it will be. Treasurer Crane state they anticipate it to be 120 basis points (1.2%).

Attorney General Wasden then moved to approve the request. Secretary of State Denney seconded the motion. The motion passed on a unanimous voice vote. All Board members and Controller Woolf acting as secretary to the Board signed the notes.
